

**TAX LEVY ORDINANCE**

**TOWNSHIP**

**ORDINANCE No. 22-03**

An ordinance levying taxes for all town purposes for Elgin Township,  
Kane County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of Elgin Township,  
Kane County, Illinois, as follows:

SECTION 1: That the sum of Two Million Five Hundred Ninety-two Thousand  
Five Hundred and Seventy-seven Dollars & 78/100 (\$ 2,592,577.78 are hereby levied upon all  
property subject to taxation within the Township as that property is assessed and equalized, in order to  
meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted  
by the people in accordance with the law, for such purposes as:
