**Meeting of November 6, 2017 Minutes**

The regular meeting of the Town of Elgin, Illinois was held on November 6, 2017, in the Board Room of the Elgin Township Building. The meeting was called to order by Supervisor Franklin Ramirez at 6:02 p.m. The Pledge of Allegiance was led by Clerk Dowling.

**ROLL CALL**

Trustee Eduardo Guerra, Trustee Jose Villalobos, Trustee Verner Tepe, Trustee Susan Van Weelden and Supervisor Franklin Ramirez were all present. **Quorum was established.**

**APPROVAL OF MEETING MINUTES**

A motion was made by Trustee Tepe to amend the minutes of the October 16, 2017 regular Board meeting. Discussion was held. A motion was made by Trustee Van Weelden to approve the minutes as printed. Motion seconded by Trustee Villalobos. Motion carried 4-1-0.

**OLD BUSINESS**

A motion was made by Trustee Guerra to approve the Audit bills/funds for the period of October 17, 2017 to November 3, 2017 in the amount of \$14,512.20 for the General town fund, \$3,941.35 for the General Assistance fund, \$2,130.73 for the Insurance fund for a total of \$20,584.28. Motion seconded by Trustee Villalobos. Motion carried 5-0-0.

A motion was made by Trustee Van Weelden to approve the Board audit report for the period of November 6, 2017 in the amount of \$14,075.02 for the General town fund, \$14,133.43 for the General Assistance fund, \$26,582.53 for the General Road fund for a total of \$54,790.98. Discussion held. Motion seconded by Trustee Guerra. Motion carried 4-1-0.

Road comments- Highway Commissioner Seyller is getting ready for winter with maintenance and service on trucks. Discussion held on why the levy tax increased by 5%.

Motion seconded by Trustee Van Weelden. Motion carried 5-0-0.

3. **Town and Road Levies**- Due last Tuesday of December. \$2,334,181.00 is what will be submitted to the county for the Town levy. Trustee Tepe made a motion to accept Tax levy ordinance #17-05.
