The meeting of the Town of Elgin, Illinois, was held in the boardroom. Supervisor Tepe called the meeting to order at 7:02 p.m.

Trustees Janice Bennett, Juan Silva and Supervisor Vern Tepe were present. Trustee Carl Strathmann not present. **Quorum was established.** Trustee Ed Hanson expected to arrive late.

- A. General Announcements: Supervisor Tepe gave reminder that with a member quorum of only 3, all votes must be unanimous.
- B. Recognize Public Comments: none
- C. A typographical error omitted highway commissioner and assessor's comments from the agenda. Highway Commissioner Krabbe gave report.
 - a. Completed the 2nd mowing of the season.
 - b. Rented a crack filling machine with Blackberry and Batavia Townships. Crack filled Kenyon, Barry, Middle, McDonald, Coombs, Kristen, Gingerwood, and Bittersweet Ln.
 - c. Rebuilt and replaced steel grate over drain in shop. Also had additional drains and plumbing along with a new hot water heater replaced.
 - d. Despite a little rain the 4th of July parade was a success.
 - e. Shouldered new pavement in Hidden Hill.
 - f. Bids for our joint project with the City of Elgin came in as expected per the engineers' estimate. Finalizing the IGA with the City.
 - g. Electrical has been run to the shed and lights and outlet have been installed. The Electrician will return Wednesday to repair light in parking lot.
 - h. The painter will start pressure washing, possibly at the end of the week.
