### **OLD BUSINESS**

Review and Audit of bills/funds. Trustee Tepe made a motion to approve the audit/bills funds for the period of 2/13/18 to 3/9/18 in the amount of \$16,095.90 for General Town fund, \$5,677.55 for General assistance, \$2,333.36 for the Insurance fun, for a total of \$24,106.81. A motion was made by Trustee Van Weelden to approve the Board audit report for the period of 3/12/18 in the amount of \$12, 252,28 for the General town fund, \$14,126,69 for the General assistance fund, \$31,141.73 for the General road fund for a total of \$57,520.70. Motion seconded by Trustee Villalobos. Discussion held. Ayes; Trustee Tepe, Trustee Van Weelden, Trustee Villalobos, Trustee Guerra, Supervisor Ramirez. Nays; None. Motion carried 5-0-0.

### **NEW BUSINESS**

Announcement of Next Annual Town meeting. Trustee Van Weelden made a motion to accept the annual town meeting agenda for April 10, 2018 at 7 pm. Discussion held. Motion seconded by Trustee Villalobos. Motion carried 5-0-0.

Budgets on file. Supervisor Ramirez, Road commissioner Seyller and Tax assessor Surnicki all working on budgets. Will have a hearing before May regular meeting. Discussion held. Have to have approved your budget by June 30, 2018. Supervisor Ramirez moved to accept the budgets on file for 30 days prior to May town meeting. Supervisor Ramirez moved to amend the motion for the budgets to be on file by April 12, 2018. Trustee Van Weelden seconded. Motion carried 4-0-1.

Assessor Surnicki noted printing cost down by 40%. Road comments; Commissioner Seyller ordered remainder of salt. County is going out to rebid salt. Checking bids for a truck. Looking at resurfacing back lot for Rodney's side and re-paving front lot.
