APPROVAL OF MEETING MINUTES

A motion was made by Trustee Tepe to approve the minutes of the Township Board meeting. Motion seconded by Trustee Van Weelden. Clerk Dowling noted that the next general meeting should have stated October 15, 2018. Discussion held. Motion carried 4-0-0.

OLD BUSINESS

Review and Audit of bills/funds. Trustee Tepe made a motion to approve the audit/bills funds for the period of 9/11/18 to 10/12/18 in the amount of \$827.52 for General Town fund, \$9,494.32 for General assistance fund, for a total of all funds \$10,321.84. Motion seconded by Trustee Guerra Ayes; Trustee Tepe, Trustee Guerra, Trustee Van Weelden, Supervisor Ramirez. Nays; None. Motion carried 4-0-0.

A motion was made by Trustee Van Weelden to approve the Board audit report for the period of 10-15-18 in the amount of \$24,749.79 for the General town fund, \$21,904.03 for General assistance fund, \$1,116.29 for Senior fund, \$46,790.14 for General road fund, \$3,222.68 for Insurance fund for a total of all funds \$97,782.93. Motion seconded by Trustee Guerra. Discussion held. Ayes; Trustee Villalobos, Trustee Guerra, Supervisor Ramirez, Trustee Tepe, Trustee Van Weelden, Nays; None. Motion carried 5-0-0.

OTHER BUSINESS

Assessor Comments, Assessor Surnicki noted the Assessor appeal period starts on Monday. He has 126 appeals. Road Comments, Road commissioner Seyller finished the brush pick up for the season. He is still waiting for the paving invoice. Commissioner Seyller purchased a new snow plow.

NEW BUSINESS

- 1. RX Program; Supervisor Ramirez moved to keep the Senior Prescription drug program. Motion seconded by Trustee Villalobos. Discussion held. Motion carried 5-0-0.
- 2. New Clerk Signature Law; The Clerk now has to attest all checks which reflect a payment. Discussion held. Supervisor Ramirez will sign, then the Clerk.
- 3. Social Service Presentation Discussion; Discussion held. Presentations will be 5 minutes for each organization with a half hour break.
- 4. Tax & Levy Discussion; Tax & Levy need to be in by Dec 26, 2018.
- 5. Elgin Township Technology Group (Seniors); Trustee Tepe noted that in discussions at the Senior Advisory Committee, with input from Cherrie Aschenbrenner, residents particularly seniors, would like to have technical classes on various subjects. It was suggested we start the 4th week in January 2019 possibly from 7-9 pm. Supervisor Ramirez made a motion to approve the Elgin Township Technology group. Motion seconded by Trustee Van Weelden.
