A motion was made by Trustee Hudgens to approve the Board Audit report for the period of 04-06-2017 through 05-05-2017 in the amount of \$20,510.14 and \$2,143.07 for General Town and General Road, respectfully for a total of \$22,653.21. Motion seconded by Trustee Johnson. Discussion was held.

A motion was made by Trustee Hudgens to approve the Board Audit report for the period of 05-08-2017 in the amount of \$59,767.94 and \$36,845.11 for General Town and General Road Fund, respectfully for a total of \$96,613.05. Motion seconded by Trustee Pelock. Discussion was held.
