# **Elgin Township Mid-Year Report**

# June 30, 2017

Food For Greater Elgin shares ongoing gratitude for its partnership with Elgin Township. The \$20,000 grant award received in December, 2016 has been instrumental in our organization's ability to continue its fight against food insecurity in our region. Together, we have changed the course of thousands of lives and provided stability to this community as a whole.

As we conclude our Fiscal Year 2017, we are honored to demonstrate the following impact:

# **Funding Request Measurements**

The following FY2017 goals were presented in FFGE's October 2016 Funding Request to Elgin Township:

- 1. Increased Senior Outreach Programs
- 2. Increased endeavors to ensure all children faced with hunger have access to Food For Greater Elgin services

- 3. Strengthening of internal protocol and practices
- 4. Construction of farmable and educational garden plots on FFGE property

Our organization is proud to provide the following demonstrations of success in reaching these goals:

1. Fresh to You Mobile Market was launched in November, 2016. Through a collaborative partnership between Senior Services Association and Housing Authority of Elgin, Fresh to You takes place every third Friday of the month at Central Park Towers in Elgin. Recognizing the challenge many low-income and disabled seniors face in getting to FFGE's facility, Fresh to You brings the client-choice, grocery store model directly to Central Park residents. Individuals are able to choose from a spectrum of nutritious food including fresh produce, meats, dairy, breads, deli and shelf stable items. Fresh to You also takes place on the fourth Friday of every other month at Gardiner Place in East Dundee. Planning is in place to reach additional sites, and also utilize the Gardiner Place location as a main hub for all Dundee area seniors in need, not just these residents.

Through the increased outreach of Fresh to You, FFGE can now demonstrate that of all clients served monthly, 10-11% are food insecure seniors versus 5-6% prior to the program launch. On average, an additional 100-150 individuals and 100 – 120 households are now receiving the stability they need monthly.

2. In partnership with school district U-46, high-risk schools and their designated personnel will receive increased information about FFGE to share with families. Plans are in motion for materials to begin being distributed in Fall 2017.

School's Out Hunger's Not campaign successfully launched with FFGE's Pallet to Palate 2017 event. Focusing on youth hunger, the event served as an educational space to bring children's food insecurity to light for the Elgin Community. A \$10,000 kick-off gift from a generous individual paved the way for the campaign. With 80% of Elgin area children on free and reduced meal plans, holidays and vacation put added strain on families already faced with hunger. Throughout the summer, families with children are able to shop in an added section of FFGE's warehouse for additional nutritious foods.

- 3. As FFGE continues to grow and develop, internal protocol for staff, volunteers and clients is continually revisited. FY2017 brought the creation of new Daily Operations Protocol for staff, volunteer protocol improvements and multiple training sessions and additional, meaningful pieces added to client intake materials and procedures.
  - In addition, FFGE's Community Resource Center received a full upgrade with a myriad of materials and information easily accessible to FFGE clients. New and additional partnerships have also been solidified with other organizations and businesses able to provide their services on site at FFGE. A full lending library was also added in partnership with Gail Borden Library.
- **4.** The gardens are in place and growing to produce FFGE's first "home grown" crop of fresh produce!

### **Additional Updates**

- Formally Facilitated Strategic Planning Sessions for Board and Staff
- Partnership to be solidified with ECC Spartan Pantry as an FFGE satellite site as of Fall2017
- Change in leadership After nearly five years with the organization, Michelle Frampton made the decision to move on from her role as Executive Director at FFGE. As the second staff person in place, Michelle worked to elevate and guide the organization from infancy to adulthood and secure its needed, recognized place in the Greater Elgin community. Joann Hartmann, one of the founders of FFGE and current Board Secretary, will serve as Interim Executive Director while a search for a new ED is conducted. Michelle will remain connected to the organization in a consulting capacity and FFGE's Board and Staff are committed to a smooth transition into the next successful chapter.

### Conclusion

Elgin Township's ongoing belief in Food For Greater Elgin's mission and service to the community is, once again, deeply appreciated. Our organization looks forward to working with the new Township leadership. FFGE is committed to this meaningful relationship, making continued strides in addressing food insecurity and working together to provide community-wide stability.


