On behalf of Elgin Township residents with developmental delays and disabilities, I would like to thank you for the \$10,000.00 social services grant. The Township's support will make a significant difference in the lives of Elgin area children with developmental disabilities and the families who love and care for them.

The number of children with a developmental disability in the US is increasing steadily. Today, one in six children in the U.S. have a developmental disability — that is 16% of all children in the country. Rates are much higher among children from low-income families, who have a nearly two-fold higher prevalence compared to those with private insurance. As more children are diagnosed each year, the demand for services is growing rapidly. 

Dear Mr. Ramirez:

I am writing you to provide a reporting of how our Elgin Parks and Recreation Foundation has disbursed the \$4,000 that you granted us last spring, through your Summer Programs for Youth at Risk Grant. As we shared in our grant application, we used the grant money the Township provided to fund the Recreation Youth Scholarship Fund, which provides financial assistance to children in Elgin whose parents cannot afford to register them for recreation programs.

The \$4,000 that you provided was distributed between the dates of July 18 and August 1. A total of 39 children participated in 69 different programs as a result of your grant to us. The various programs and services that they participated in were as follows: pool passes, Centre Jr. memberships, fitness memberships, summer camps, climbing wall classes, swim lessons, martial arts, soccer and basketball.

I want to thank you, and the other Elgin Township Trustees, for providing the grant funding so an additional 39 Elgin children could participate in the recreation program of their choice during the summer of 2017.
