## Dear Mr. Ramirez:

I am writing you to provide a reporting of how our Elgin Parks and Recreation Foundation has disbursed the \$3,500 that the Elgin Township so generously granted us last spring, through your Summer Programs for Youth at Risk Grant. As outlined in our application all of those funds were used to support the Elgin Recreation Youth Scholarship Fund, which provides financial assistance to children in Elgin whose parents cannot afford to register them for recreation programs.

The \$3,500 that you provided was distributed between the dates of May 9 and May 29. A total of 46 children registered for 61 different programs through your grant funding. The various programs and facilities that they choose to be a part of were as follows as follows: pool passes, Centre Jr. memberships, swim lessons, fitness memberships, summer camps, dance classes, boxing, gymnastics, painting, soccer and basketball.

I want to thank you, and the other Elgin Township Trustees, for providing the grant funding so an additional 46 Elgin children could participate in the recreation program of their choice during the summer of 2018. As I am sure you are aware, keeping our youth involved in healthy activities benefits both them and our community.
