

TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE NO. 18-07

An ordinance levying taxes for all road purposes for Elgin Township Road District Kane County, Illinois, for the tax year 2018, collectable in 2019.

BE IT ORDAINED by the Board of Trustees of Elgin Township, Kane County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Elgin Township Road District on November 5, 2018 does hereby determine and declare that the sum of One Million Five Hundred Fifty Seven Thousand Seven Hundred Eighty Seven Dollars & 00/100 (\$ 1,557,787.00).

are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:


