The Consumer Price Index (CPI) "cost of living" or inflation percentage to use in computing the 2019 extensions (taxes payable in 2020) under PTELL is 1.9%

Section 18-185 of the Property Tax Code defines CPI as "the Consumer Price Index for All Urban Consumers for all items published by the United States Department of Labor." This index is sometimes referred to as CPI-U. Section 18-185 defines "extension limitation" and "debt service extension base" as "...the lesser of 5% or the percentage increase in the Consumer Price Index during the 12-month calendar year preceding the levy year..." (emphasis added).

For 2019 extensions (taxes payable in 2020), the CPI to be used for computing the extension limitation and debt service extension base is 1.9%. The CPI is measured from December 2017 to December 2018. The U.S. City Average CPI for December 2017 was 246.524 and 251.233 for December 2018. The CPI change is calculated by subtracting the 2017 CPI from the 2018 CPI. The amount is then divided by the 2017 CPI which results in 1.9% CPI. (251.233-246.524)/246.524=1.9%.

The Boys & Girls Club of Elgin's Junior Staff Program has a goal of developing a qualified, competent and committed workforce needed to fulfill the mission of the BGCA movement. It is available to 8th-12th grade students. They were invited to apply at the end of the spring 2019 semester, were interviewed, and hired to be part of the 2019 Summer Junior Staff Cohort. Throughout the nine week summer program, they were exposed to opportunities and hands on working experience in the following areas:

- Career development
- Apprenticeship
- Customer service
- Community service

Our teens met four times a week to build career development skills in small group workshops, learning about leadership styles, college and career prep, confidence and professional image, growth mindset, and race and discrimination in the workplace. After each workshop, our Junior Staff students either mentored younger Club members or visited local businesses in the community. The local businesses include Hoffer Plastics, Dream2Be, Woodfield Mall, Elgin Visitors Bureau, Soulful Sparrow, Vida Yoga & Fitness, Advocate Sherman Hospital, Side Street Studio Arts, Animal Clinic of South Elgin, and Gail Borden Public Library.



End of Grant Period Report

Making Kane County Fit for Kids collaborates with community partners to implement healthy eating and active living projects that align with the Fit Kids 2020 Plan and reduce Childhood Obesity. Requests for Proposals to implement Fit Kids 2020 Plan strategies were announce through Kane County communications in April, 2019 with a due date of May 24, 2019. Six Projects were approved for Making Kane County Fit for Kids funding of \$48,369 at a Board of Directors meeting on June 12, 2019.

- Aurora Whole Child Fitness Initiative: Exercise Equipment Blackhawk Academy
- Aurora Keep Them Fit: Heart Monitors West Aurora High School
- Aurora Growing Healthy Families: Garden Equipment / Items YWCA Metro Chicago 2 Aurora sites
- Batavia Encourage Bike/Scooter to School: Scooter Racks Batavia Bicycle Commission
- Elgin Community Demonstration Kitchen: Equipment & Startup Food Costs Well Child Center
- Elgin Move, Play, and Talk Project: Playground Panels/Signage/Interaction Elgin Partnership for Early Learning & Alignment Collaborative for Education

Elgin Township's \$5000 grant funding was utilized and expended in support of two Elgin projects.

<u>Project 1</u>: Community Demonstration Kitchen, Equipment & Start up Food Costs Creating an Ideal Environment for promoting and preparing Healthy Meals. Partner: Well Child Center

Elgin Township Monies: \$4,295

Monies to be used for commercial dishwasher with installation, multi cooker, commercial blenders, crockpots, electric skillets, kitchen utensils, pans, and initial food costs.

<u>Project Goals:</u> Increase healthy eating behaviors, perceptions about lifelong nutrition and improve the nutritional status of pregnant women, new mothers, newborns, and young children. Engage 550 of eligible participants in experiential learning opportunities. Improve food resource management skills and behaviors. Host 22 healthy cooking demonstrations through hands-on-training and incorporating recipes using food items from Food for Greater Elgin's mobile pantry.

<u>Target Population</u>: Well Child Center's initial target population for this collaborative project is 300 pregnant WIC clients they serve annually and monthly WIC cooking classes to 250 WIC clients and mothers of dental patients. Well Child Center's concept for healthy food access, tailored education and cooking demonstrations specifically targets high risk subgroups.

<u>Project 2</u>: Move, Play, & Talk Playground Project <u>Partner: EPEL and Alignment Collaborative for Education</u>

Playground Panels/Signage/ Interaction at Festival Park's Playground Environment

Elgin Township Monies: \$705

Other Fit for Kids donors contributed additional \$11,195

Monies to be used for teaching playground panels that encourage families to move, play, and talk with their children. In addition to the panels, fencing and playground framework will be used to install a minimum of 12, teaching moment opportunities where children learn about fitness, nutrition, and wellness while they also learn reading and math concepts.

<u>Project Goals</u>: Use non-traditional settings such as playgrounds that provide a safe and secure environment for families to get active. Promote unstructured play and family communication opportunities through the use of playground panels that provide teachable moments to children. Objectives include helping families boost their children's early brain development and strengthening language development while learning more about fitness, nutrition, and overall wellness.

<u>Target Population</u>: The Move, Play and Talk project will serve the geographical area surrounding Festival Park plus the Greater Elgin Community – an estimated 1,100 preschool children. Six U-46 elementary schools are in close proximity with total enrollment of 2,622 students. This population is challenged by the need for greater financial resources with the average free and reduced lunch percentage at 90%.
