Centro de Información - Ms. Dianha Ortega-Ehreth spoke regarding update. 9 seniors in Elgin Township were helped, 14 seniors in city of Elgin were helped.

Dementia Friendly Elgin Area - Glenna Godinski and Dr. Susan Wesner spoke on behalf of the organization. Representatives spoke of giving Tote Bags, Medical File Keepers and Nail Files. GPS Tiles to locate wandering seniors was explained with cost of \$35 per Tile. Joy for All animatronic cat was explained on how it helps seniors with dementia. UMAS (Universal Metro Asian Services) - Ms. Roshita Pandey and Ms. Urvashi Bhatt spoke regarding update. 40-50 Elgin Township residents requested more information/assistance.

Elgin Men's Shed - Mr. Paul Reardon spoke regarding update. Currently 24 active members, dues \$60 annually. The oldest being 92 years old. Helping by socializing and addressing Men's health and loneliness. Committeeman Rowe asked if it was exclusively a men's group and it is open to women as well. Mr. Reardon spoke about the women who are active in this group. Funds were also used for safety items. Lack of space was discussed due to growth of organization. Spoke about Game Days Event

Food for Greater Elgin - Mr. Michael Montgomery spoke regarding update. Example of a food box was presented. Discussion of the impact of inflation was held, 3,000 more requests year over year, eggs cost increase, national policy of elimination of COVID SNAP extension. Approximately 20,000 seniors are helped with food.

Senior Services Associates - Ms. Mickey Miller and Ms. Beth McClory spoke regarding update. 421 Elgin Township residents attended recreational events in 2022 funds were used for many purposes including but not limited to paying staff, marketing outreach and website maintenance.

Kane Senior Council - Ms. Tasha Samuels spoke regarding update. 390 Seniors were being helped, 77% of organization's goal. 22,000 meals and 12,000 well-being checks were performed last year. Senior dance party event was mentioned as a way of socialization.

E. FOIA, OMA and Sexual Harassment Prevention Training Online - Deputy Clerk Mihalec updated committee of members status. Illinoisattorneygeneral.gov is the website to fulfill requirements. After members get their certificate, they are required to send to Deputy Clerk Mihalec.
