The meeting of the Elgin Township 708 Community Mental Health Board was held in the lower level of the Township Building. The meeting was called to order by Chairman Andrew Sosnowski at 7:05 p.m. Chairman Andrew Sosnowski led the Pledge of Allegiance.

Chairman's Report: The Chairman thanked everyone again for their hard work on completing the needed documentation for the board. He also reminded everyone that we would be having speakers from various local mental health organizations speak at the next couple of meetings.

A. Presentations

- 1. Bernadette May/ Family Services Association of Greater Elgin- She presented a powerpoint presentation that is available for review. The organization provides a full array of comprehensive, outpatient mental health services, that include outpatient therapy, screen assessment, and support, school-based therapy, mental health juvenile justice, and community mentoring An item of note is that this organization services two areas that they have identified as gaps in service in the areas. These include working with populations that are underinsured and providing preventative care.
- 2. Deb Howe/ Ecker Center for Behavioral Health- She presented a powerpoint presentation that is available for review. They are a behavioral health organization that offers an array of comprehensive services for youth, adolescents, and adults. These services include services for those in crises, residential programs, a wide variety of psychiatric and mental health services, services for substance abuse and gambling, and a variety of other programs and services.

Items of note include that they utilize two types of state grants. One being a "Fee for Service" grant where they provide a service and are reimbursed for it. The other kind is an "Expensed Based grant" which is very structured and detailed on how the funds can be spent.
