Payment Agreement

Client, (hereinafter "Client") shall be solely liable for the timely payment of all amounts invoiced under this proposal. Invoices will be tendered by ENCAP, Inc. ("ENCAP") from time to time, but no more frequently than every two weeks, and shall be due and payable upon receipt. If Client objects to all or any portion of an invoice, Client shall nevertheless timely pay the undisputed amount of such invoice and promptly advise ENCAP in writing of the reasons for disputing any amount.

Client shall pay an additional charge of two (2) percent (or the maximum percentage allowed by law, whichever is lower) of the invoiced amount per month for any payment received by ENCAP more than thirty (30) calendar days from the date of the invoice, excepting any portion of the invoiced amount in dispute and resolved in favor of Client. Payments shall first be applied to accrued interest and then to the unpaid principal amount.

Dear Trustees of Elgin Township,

Thank you for your very generous support for our summer programs for at-risk children in Elgin Township. We are very grateful for your generosity and making it possible to serve kids and families in the midst of such a challenging time.

For over 40 years we have provided our free summer camp and teen leadership programs for young children and teenagers from low-income families throughout the Fox Valley. This summer, due to Covid-19, we adapted our programs to serve in new ways. We were able to serve kids and families in three ways this summer:

<u>Family Overnights:</u> We were able to provide 36 families from our communities with a short get-away on our campus with all of their meals and activities included. It was a new and beautiful opportunity for us to see the families experiencing camp together! **Eight families from Elgin Township received a free Family Overnight this summer.**



<u>FVCA PACKS</u>: We couldn't bring the young kids to camp, so we worked with 10 church partners and over 200 volunteers to put together FVCA PACKS: duffle bags filled with arts & crafts supplies, a new sleeping bag, snacks and other materials to go along with a Gospel presentation and activities that kids could do with online video instructions! The contents of the PACKS are valued at well over \$50 each. By God's grace we assembled and personally delivered PACKS to 928 kids in our communities! We estimate that approximately 300 children received these PACKS in Elgin Township.

<u>Teen Leadership</u>: We were also able to provide our middle school and high school students with two packed weeks of leadership programming in a day camp format. We're so grateful to have this opportunity to speak into the lives of the teens and thankful for their commitment to participate in this revised format!

Teens came for four "long days" (9 am - 7 pm), Monday - Thursday, for two weeks. The teens participated in activities including virtual college tours & career exploration, socially distanced group games, scavenger hunts, canoeing, pontoon boat rides, Bible lessons and small group discussions, hiking in the woods, biking, crafts, and creating a vision board for their future. 30 middle school and high school teens participated in the program with 7 coming from families in Elgin Township.



As we shared in our update letter in June, due to the unusual circumstances and changes in programming this summer, with your permission, we would like to apply your generous gift to these "revised activities" for the summer of 2020. Please let us know if you have any concerns or need further information about how we have applied your gift to these activities.
