Senior Tax Referendum: Township Attorney Mark Schuster was present to lead discussion on "Resolution 2017-1 TO PROVIDE FOR THE SUBMISSION OF A PUBLIC QUESTION TO THE VOTERS OF ELGIN TOWNSHIP, KANE COUNTY,ILL. AT THE CONS OLIDATED ELECTION TO BE HELD ON APRIL 4, 2017 TO AUTHORIZE THE LEVY OF A NEW TAX FOR THE SOLE AND EXCLUSIVE PURPOSE OF PROVIDING SERVICES TO SENIOR CITIZENS IN THE TOWNSHIP. "Discussion followed. Assessor Surnicki gave an overview of the number of senior exemptions as related to number of parcels. The estimated revenue for referendum will be approximately \$419,695. The new estimated tax rate in a Tax Cap County will be 0.025 (125%). Also present was Bette Schoenholtz, director Senior Services of Elgin.
