The annual meeting of the Town of Elgin, Illinois, was held on April 9, 2019, in the Lower Level of the Elgin Township Building. The meeting was called to order by the Township Clerk, Karen Dowling at 7:00 p.m. the published time.

Clerk Dowling led the audience in the pledge of allegiance.

At the Township Building in the presence of 11 electors the following business was conducted:

**READING OF PUBLIC NOTICE**

Public notice was read.

**ELECTION OF MODERATOR**

A. Oath of Moderator; Clerk Dowling opened the floor for nominations for Moderator. A motion was made by Denise Habun and seconded by Janice Bennett to elect Susan Van Weelden to serve as Moderator. With no other nominations from the floor, Frank Imhoff made a motion to approve Susan Van Weelden as Moderator. Motion seconded by Denise Habun. Motion carried. Clerk Dowling administered Oath of Office. Susan Van Weelden signed Oath and assumed the Chair.

Voice vote all ayes, motion carried.

2. Road Commissioner Rodney Seyller accomplished all snow and brush removal. Equipment has been maintained & parking lot has been repaved.
