The regular meeting of the Town of Elgin, Illinois was held on December 11, 2017 in the Board Room of the Elgin Township Building. The meeting was called to order by Supervisor Franklin Ramirez at 6:00 p.m. The Pledge of Allegiance was led by Clerk Dowling.

**ROLL CALL**

**APPROVAL OF MEETING MINUTES**

A motion was made by Trustee Guerra to approve the Board audit report for the period of December 11, 2017 in the amount of \$445,510.34 for the General town fund, \$12,774.75 for the General Assistance fund, \$234,193.77 for the General Road fund for a total of \$692,478.86. Discussion held. Motion seconded by Trustee Van Weelden. Aye's; Trustee Van Weelden, Trustee Guerra. Trustee Tepe, Supervisor Ramirez. Nay's; None. Absent Trustee Villalobos. . Motion carried 4-0-0.
