- 6/30/19 Budget Hearing & Adoption
Last day to conduct budget hearings and adopt Township and Road District budgets. Budgets may be adopted before or during the first quarter of the fiscal year. The Township budget may be adopted at the public hearing. The Road District budget shall be adopted at the public hearing.
- 6/30/19 Prevailing Wage Act- Adopt Ordinance
Last day for board to adopt ordinance of intent to comply with the Illinois Prevailing Wage Act. Ordinance must be adopted during June and filed with the Index Division of the Secretary of State and Illinois Department of Labor.
- 7/30/19 Budget Filing
Last day to file certify budget and revenue sources with the County Clerk if budget is adopted at end of June. Must be filed with the County Clerk within 30 days of adoption. Therefore, filing deadline varies with the date of adoption. Clerk certifies the budget and supervisor certifies the revenue sources.

9/30/19 Annual Treasurer's Report Compiled & Published/Audit

Last day for the supervisor to prepare the combined Annual Treasurer's report for Township and Road District. Report must be completed within 6 months from end of the fiscal year and filed with County Clerk's office. Last day for Township's to file CPA audit with State Comptroller's office and County Clerk.

Last day to hold Truth in Taxation hearing, adopt and file Township and Road District certificates of levy, tax levies, and Certificate of Compliance for Truth in Taxation Law with County Clerk.
