

**TAX LEVY ORDINANCE**

**TOWNSHIP**

**ORDINANCE No. 17-05**

An ordinance levying taxes for all town purposes for Elgin Township,  
Kane County, Illinois, for the tax year 2017, collectable in 2018.

BE IT ORDAINED by the Board of Trustees of Elgin Township,  
Kane County, Illinois, as follows:

SECTION 1: That the sum of Two Million Three Hundred Thirty Four Thousand  
One Hundred and Eighty One Dollars & 00/100 (\$ 2,334,181.00 ) are hereby levied upon all  
property subject to taxation within the Township as that property is assessed and equalized, in order to  
meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted  
by the people in accordance with the law, for such purposes as:

for the year 2018.

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of

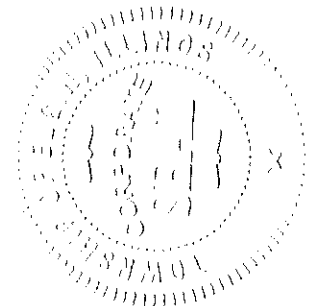
Kane, on or before the last Tuesday of December, a duly certified copy of this ordinance.

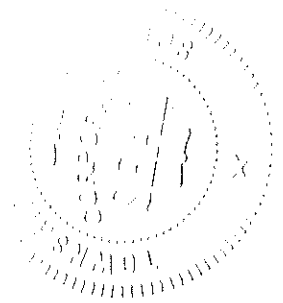

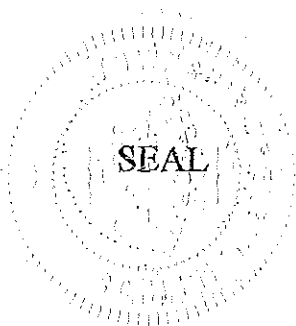


